ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Yiter Lombi, Library Guwahati High Court Permanent Bench Itanagar for non-furnishing of information by Shri Dakli Kato, the SPIO-cum-EE(PWD) Govt. of A.P. Basar Division, Leparada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/11/2022 regarding C/o Daily Market shed at Tirbin, Distt-Leparada, Arunachal Pradesh.

The 7th hearing is held today on 18th June' 2024 (Tuesday) at 1030 hrs. Shri Kengo Bam, AE, represented the PIO-Cum-EE (PWD) Govt. of A.P.Basar Division, Leparada District, Arunachal Pradesh. The representative of the PIO has submitted that all the available information under the control of the PIO has been furnished to the Appellant regarding land available certificate at Sl. No. 10. in form "A" application. The PIO has submitted that it was donated by the land owner and in return, he was given work order for construction of the Market Shed. But they could not obtain the Land Possession Certificate at that time. Further, said that land owner has been under medical treatment, so there may not be in position to provide LPC as sought for by the Appellant. The Appellant is absent. As per the directions the case is to be disposed of without any further notice incase the Appellant is absent. Today the Commission decides to disposed of the case with the directions to the PIO to furnish the information regarding the LPC for Market Shed within 15 days from the date of issue of this order directly to the Appellant with an intimation to the Commission.

Hence, the case is disposed of and closed.
