ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P. O/o BDO Dari CD Block, Leparada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/01/2023 regarding expenditure & implementation under MG-NREGA/ Supply work / Pending work / New work / Sanction order/ Compete work.

The 2nd hearing is held on 17th October, 2023 as scheduled. Ms. P. Mary Bui, the SPIO-cum-BDO, Govt. of A.P. O/o BDO Dari CD Block, Leparada District, Arunachal Pradesh alone is present and the Appellant Shri Tania June is found absent. The SPIO has submitted that as per the directions of the Commission, she has made all arrangements to provide the information to the Appellant and further stated that she has given intimation to the Appellant also. During the last hearing it was clearly directed to both the parties for strict compliance of the directions of the Commission. Failing to which SPIO shall be initiated penal action and incase Appellant found absent the case will be disposed of. As per the submission of the SPIO she has complied with the Commission's direction and Appellant has failed to do so. Hence, the case is disposed of with the direction to the SPIO to furnish the information to the Appellant on deposition of requisite fee to her office.
