Information sought: The appellant filed an RTI application dated 26.08.2024 seeking following information regarding RE/BE.

Details of information Required:

- 1. Furnish the List of Scheme.
- 2. Give the Name of Work List with Geo tag Report/ Sanction Order/Technical Sanction (TS) order copy.
- 3. Details of Project Report (DPR)/Estimate copy.
- 4. Furnish the List of Work Order copy with Cheque book counterfoil/leaf /demand draft/Banker cheque/deposited slip/Challan and PFMS Transaction details as according to the Amount which Mentioned in Work Order/Sanction Order/Name of work list.
- 5. Furnish Name of Contractors/Firm/ Enterprise with their bank account number.
- 6. Give the deposited Slip/Voucher/Treasury Challan of GST Amount/Money which deposited to Govt. Account against Royalty by Firm/Enterprise account with GST updates.
- 7. Give the Xerox copy of all the Trading License/Firm/Enterprise.
- 8. Furnish the Deposited slip/Challan /voucher/Transaction of GST Money deposited to Government Account against Royalty by Executive Engineer, division Account/Firm/Enterprise Account and also Mention the Owner Name of firm/enterprise/Proprietor Name, give reason What Firm /Enterprise Owner/Proprietor is to AE/JE who run the Firm /Enterprise?
- 9. Details of Payment with Money Receipt of Contractors/Firm/Enterprise.
- 10. Give Bank Account Statement of EE Division with Its Account Number.
- 11. Give the Letter/petition/LOC/LOA which wrote to the Branch Manager of State Bank of India to Release of Fund to Executive Engineer Account by Chief Engineer PWD.
- 12. Give Measurement book (MB) with page number/Hand Receipt and Payees Name.
- 13. Give First & Final Bill Copy/Give the Name of various Deduction as percent from Contractor payment.
- 14. Give the Photocopy of Work Site before Starting of work /Completion of work site with exact location.
- 15. Give Certified Photocopy of all work Site by concern Officer.
- 16. Give the Name of Officers and Officials who handled/Executed the Works.
- 17. Furnish the Description of worksite location before start of work.
- 18. Furnish the Billing details Sheet copy of works.
- 19. Give the Bank Account Statement and Amount Transferred to Respective Bank Account of Various Assistant Engineer (AE) Sub-Division from Executive Engineer on Account of Division/Firm/Enterprise Account with its Bank Account Number.
- 20. Give the List of AE/JE of department with their Used Firm/Enterprise.
- 21. Furnish NIT Copy/Date of NIT Tender float/Total number of Bidder/Total Apply of Firms/Name of Selected Firm/Enterprise & Contractors/Press Letter Paper Cutting/Awarded FIRM Details/Cheque book counterfoil/leaf with

Account Number of Firm or Contractor to whom the payment has been made / UC.

Period from which information asked for: 2021 to 2022.

: Absent. Represented by Bini Tare, PA cum in charge RTI Cell, PWD, Sangram. He states that the information sought is very voluminous thus, he has requested for 45 days time to furnish the information.

FAA

: Absent. Represented by Shri T. Takuk, ASW, PWD, CZ-A. He states that the appeal case was heard and disposed of at FAA level. He has produced a copy of order dated 18.11.2024 of FAA-Chief Engineer CZ-A, PWD AP.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records observes as follows:

- 1. Chief Engineer, CZ-A PWD AP, as first appellate authority has duly heard the appeal case on 18.11.2024 wherein he has rejected the appeal on the ground that the application sought is for various projects and is voluminous and is not for "one scheme and one financial year".
- 2. FAA Chief Engineer, CZ-A PWD AP is exempted from appearance for further hearing on this appeal case.
- 3. The information sought is scheme funding program under state plan BE and RE for one financial year 2021 -22 which should be provided to the appellant.
- 4. The PIO is directed to furnish information to the appellant within 30 days from the date of issue of this order i.e on or before 23.02.2025.

Hearing adjourned. Next date of hearing shall be fixed in due course of time. Order pronounced in the Open Court of this Commission today this 23rd day of January' 2025. Each copy of the Judgement / Order be furnished to the parties.
