Height Const. of RCC foundation, Chain link & security fencing, Pump House & Pvdg. & supplying i/c installation of 5 HP Solar Pump & civil works. (Under SIDF)

Period for which information asked for: -2022-23.

The following were present.

**Appellant**

: Present. He states that the PIO has not facilitated the work inspection earlier as ordered by the FAA. However, he has produced a copy of work inspection notice fixed by the PIO later after receipt of summon for today's hearing.

**Respondent PIO**

: Shri Bhupen Khamyang, AE / APIO represented the PIO through VC. He states that the work inspection by the appellant shall be facilitated.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that FAA has heard the first appeal and disposed of at his level by directing the PIO to facilitate work inspection by the appellant. The PIO has furnished all the information as sought in RTI



application. As already agreed, the PIO is directed to facilitate work inspection by the appellant within 15 days from the date of issue of this order. Since all the information sought is already received by the appellant and the PIO agreed to facilitate work inspection, and as also prayed by the appellant this appeal case is fit to be closed and disposed of.

**The appeal is disposed of accordingly at Commission.**
