**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Buli Bhai, G-Extension, PO/PS-Naharlagun, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO –cum-DFO, Raga Division, Kamle District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 28.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“Expenditure & Implementation under CAMPA/VRF/ARF of entire Kamle District for the period 2008 to 2023 (till date).”**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing of this case was held on the 21<sup>st</sup> day of Dec'2023. The appellant was present but the PIO was absent. The case couldn't be heard as no PIO is appointed till date as some portions of the Forest are dealt by DFO Ziro & DFO Daporijo. So, this case is disposed of with a liberty to the appellant to file a fresh case seeking information specifically to the concerned DFO's. Hence, the case is disposed of.

*Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
