Order of the second hearing: *"The commission observes that there appears to be certain discrepancies in the submission of both the parties, while the appellant states that he has not received information till date, the PIO has claimed that required information had already been received by Shri Abang Yongfo who is said to be the friend of the appellant. Under the circumstances, the commission feels that it is necessary for both the parties to be present during the hearing for proper adjudication of the issues in the matter."*

The following were present.

Appellant : Present. He states that the information is not furnished to him. On interjection he has confirmed from his representative Shri Abang Yangfo who attended previous hearing of having received the information document and prayed for closure of this appeal case.

Respondent PIO : Absent. Shri Majik Talit, RFO represented the PIO. He was not conversant with this appeal case.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing and perusal of the records, observes that the representative of the appellant during previous hearings have already received the information.

The appeal case is disposed of accordingly at commission.
