ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Koti Mize, Village Riga, PO-Riga, PS-Boleng, Siang District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DPDO, Govt. of A.P., Boleng, Siang, District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 04/05/2023 regarding 14<sup>th</sup> & 15<sup>th</sup> Finance Commission.

The 4<sup>th</sup> hearing is held today on 4<sup>th</sup> April, 2024 as scheduled. Shri Jacob Tabing, the PIO-cum-DPDO, Govt. of A.P., Boleng, Siang, District, Arunachal Pradesh, is represented by Ms. Mihin Sonia, Member secretary-cum-CO Riga, Govt. of A.P., Siang, District, Arunachal Pradesh. The appellant Shri Koti Mize is present. During the last hearing on 11<sup>th</sup> March, 2024 the PIO has furnished certain information to the Appellant. After receiving the information the Appellant appealed the Commission to grant time for verification of the same but he has not complied with the direction of the Commission. Today the Appellant has submitted that he has not received information for the 14<sup>th</sup> Finance Commission. The PIO has submitted that the information for 14<sup>th</sup> Finance Commission which are available in the office of the PIO has already been furnished, other information which are very old and not traceable could not be furnished.

The Commission, after hearing the submission of both the parties and documents available decides to dispose of the case with the liberty to the Appellant to apply fresh application to the PIO seeking specific information which are not furnished to him.

**Therefore, the case is hereby disposed of.**
