This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, PO/PS-Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/11/2023 regarding the 14th Finance Commission in the year 2018-19 and 2019-20.

2). The 4th hearing was held on 3rd June' 2025 (Tuesday) at 1100 hrs. Ms.Nang Kalyani Namchoom, ADC, represented the District Panchayat Development Officer, Namsai District, Arunachal Pradesh was present through Video Conferencing (on hybrid mode of hearing).

3). The Appellant Shri Mamu Sono was not present in the court. However, the Appellant had submitted a representation letter vide No. Nil Dated 2nd June' 2025 addressed to the Commission informing that he had received all the information copy from the PIO-Cum-DPDO, Namsai and that he is fully satisfied with the information so furnished by the PIO and requested the Commission to dispose of the case.
