- g) The copies of Govt. order. No. regarding in the constituting a committee to regularize the service or appointment.
- h) The copies of file noting of appointment made etc.
- i) The copies of writing and viva voice test.
- j) The copies of note sheet of minister, MLA against the appointment made etc.
- k) The copies of sports certificates submitted by the candidates at the time of appointment made with institutions name if any so far.
- I) The copies of DPC with seal and sign of all the board members to constitute a committee for appoint and promotion as a regular.

Period for which information required: Since appointment to till date.
