JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Adv. Toko Nikam, Nikia Complex, Opp.Forest Nursery, Papunallah (Naharlagun ICR), Arunachal Pradesh**, for non-furnishing of information, by **The PIO-O/o The Chief Engineer, Urban Development & Housing, Mowb-II, Itanagar, ICR, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 19.07.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Annual property return filed by the Chief Engineers".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing was held on 21st day of December' 2023. Both the parties were present. Heard both the parties. Heard both the parties. The Court after vehemently going through the case directed that the matter will be discussed first with other HSICs and further proceedings on the matter will be updated accordingly. As such, the Court fixed another date of hearing for the case on 24th January' 2024.

The 02nd hearing was held on 24th day of January' 2024. The appellant was absent but the PIO was present. The case was heard ex-parte. The Court after going through the case gave ex-parte verdict whereby upholding the judgement provided by the FAA-cum-CE(UD&Housing) on 21st November' 2023 for disposing of the case(attached herewith). As such the case APIC-1123/2023 is disposed of and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
