**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Sonu, C/o Smti Teli Lina, near Govt. middle school lekhi, Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(PHE & WS), Govt. of A.P., Department P.H.E. & WS Division Basar, Lepa Rada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/02/2023 regarding **tender and Non-tender from Package-IV, PWS at Raane village, LepaRada Dist.**

The 2<sup>nd</sup> hearing is held today on 26<sup>th</sup> March, 2024 as scheduled. Shri Bommi Nyorak, the PIO-cum-EE(PHE & WS), Govt. of A.P., Department P.H.E. & WS Division Basar, Lepa Rada District, Arunachal Pradesh is represented by Shri Toko Taje, APIO-cum-JE. The Appellant Shri Nabam Sonu is absent. The APIO in reply to Show Cause to the PIO submitted that during the 1<sup>st</sup> hearing the PIO was out of station and the APIO was not directed to appear before the commission. Further the APIO submitted that all the information as sought by the Appellant has already been furnished through postal service in his address on 12/04/2023. As an evidence to his submission, the APIO place the records of postal service before the commission.

The appellant is found continuously absent. Despite cautioned to dispose of the case ordered in the 1<sup>st</sup> hearing held on 16<sup>th</sup> January, 2024 if he remains absent in the 2<sup>nd</sup> hearing the appellant has remained absent. The Commission decides to dispose of the case in view of larger public interest. Presuming that the information so furnished on 12/04/2023 is received by the appellant

**Therefore, the case is hereby disposed of.**
