ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Tai Shiva, R/o Lekha-Tomru, Segment/village Doimukh, PO & PS DMK, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Under Secretary (HPD), Govt. of Arunachal Pradesh, Department of Hydro Power Development, AP Civil Secretariat, Itanagar. Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/08/2024 regarding Implementation of Funds receipts for 12% free power supply of home state and 1% Local Area Development Fund (LADF) from Power Developers in the State of Arunachal Pradesh.
- 2). The 1st hearing was held on 18th February, 2025. The PIO-cum-Under Secretary (HPD), Govt. of Arunachal Pradesh, Department of Hydro Power Development, AP Civil Secretariat, Itanagar. Arunachal Pradesh was represented by Shri Radhe Chobin, JSA. Er. Lemgo Loyi, the PIO-cum-AE (Monitoring), Department of Hydro Power Development, Jal Vidhyut Bhawan, Itanagar was present. The Appellant Shri Tai Shiva was absent.
- 3). The JSA representing the PIO submitted that previous PIO haD been transferred and new incumbent has not yet joined the duty. The JSA also submitted that the information as sought for by the Appellant falls under the jurisdiction of the Chief Engineering (Monitoring), Department of Hydro Power Development, Jal Vidhyut Bhawan, Itanagar. Therefore, the Application of the Appellant was forwarded vide M/No-SHPD-11017/3/2021(Comp.No.11334)/662-63 dated Itanagar, the 30th August, 2024.
- 4). Er. Lemgo Loyi, the PIO-cum-AE (Monitoring), Department of Hydro Power Development, submitted that information under the jurisdiction of his office was furnished to the Appellant and the remaining information not under his jurisdiction was forwarded vide Mcmo No. CE(M)/HPD/W-117/RTI/2020-21/pt-IX/385-88 dated Itanagar, the 11/09/2024 to concern authorities with Para wise elaboration. A copy was also served to the Applicant with detailed explanation.

- 5). The Commission in view of documents available on file, submissions of the PIOs, and documents placed before the court by the PIOs, observed that the Appellant had filed application to the wrong public authority. The PIOs have diligently performed their duties.
- 6). The Commission hereby decides to ex-parte dispose of the case.

Therefore, the case is hereby disposed of.
