JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office, E-sector Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-BDO, Parsiparlo CD Block, Kurung Kumey District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 17.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work from 2014 to till date. “

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. Both he PIO and appellant were present. After hearing both the parties, the PIO had been directed by the Court to provide the information as sought by the appellant which is available in his custody and the information which are not available in his custody should be forwarded to the appropriate authority where the documents can be found. The appellant also requested for the hard copies of the documents and the Court has directed the PIO to do the same on or before the next date of hearing of this case. The next date of hearing of this case is fixed on the 20th day of Dec'2023.

The 2nd hearing of this case was held on the 20th day of December'2023. The appellant was present. The representative of the PIO, Shri Dongche T. (BFT Parsiparlo CD Block) was also present. After hearing both the parties, the representative of the PIO had provided the information as sought by the appellant during the Court proceedings itself. The appellant received the same and after going through the same, he stated that he is fully satisfied with the information provided by the PIO and further pleaded before the Court for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
