JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Gil Tamin, Mongku Village, Pasighat, PO/PS- Pasighat, East Siang District, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-O/o The Disaster Management, Pasighat, East Siang District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 16.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Relief fund under SDRF & NDRF".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing was held on 21st day of December' 2023. Both the parties were absent. DDMO, Mr. T. Tashi attended the case on behalf of the PIO. The case was heard ex-parte. Since the appellant was absent the matter couldn't be heard further. As such, the Court fixed another date of hearing for the case on 24th January' 2024.

The 02nd hearing was held on 24th day of January' 2024. Both the parties were absent. The Commission received an application(enclosed) from the appellant whereby expressing his satisfaction for all the documents received and further pleaded for disposal of the case. Hence, the Court directed to dispose of the case. Therefore, the case is disposed of and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
