ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri TamchiGungte, Near KV-II School Chimpu, PO/PS Chimpu, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-Project Director, Govt. of A.P., DRDA Tawang, Tawang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/04/2023 regarding “**List of projects / works sanctioned under Pradhan Mantri Jan VikasKaryakram (PMJVK), earstwhile-MsDP CSS Scheme during the Financial year 2017-19.**”

The 2nd hearing is held today on 19th March, 2024 as scheduled. The SPIO-cum-Project Director, Govt. of A.P., DRDA Tawang, Tawang District, Arunachal Pradesh is present. The appellant shri Tamchi Gungte is absent. The PIO has reiterated that he has made information ready to be furnished and intimated to the appellant on 22nd May, 2023 to deposit the requisite fee for the information and collect the same from the office of the PIO just after receipt of the application of the appellant dated 28/04/2023. But, the appellant has neither reported, nor deposited the requisite fee for the information.

The PIO has again brought all the hard copies of the information to be furnished to the appellant. But, information could not be furnished as the appellant is again absent for the 2nd consecutive time.

The commission in observance of the continuous absence of the appellant without any prior intimation to the commission and in view of the cautioned issued in the last hearing that the case shall be disposed of if the appellant remains absent in the hearing. The commission hereby disposed of the case with liberty to the appellant to deposit the requisite fee and collect information from the office of the PIO.

Therefore, the case is hereby disposed of.
