JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Dongru Tania, Near Takar Complex, PO/PS-Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-BDO, Gangte CD Block, Kra Daadi District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 09.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work from 2014 to till date. "

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. The representative of the PIO, Shri Biki Tadam EO(RE) was present. The appellant was also present. After hearing both the parties, the documents as sought by the appellant were brought by the representative of the PIO, and the handed over to the appellant during the Court proceedings itself. The appellant received the same and was directed by the Court to go through the same and inform his satisfaction/dissatisfaction on or before the nest date of hearing of this case. The next date of hearing of this case was fixed on the 20th day of Dec'2023.

Later, on the 20th December'2023 before the 2nd hearing of this case the appellant submitted an application (copy enclosed for ready references) intimating to dispose of the case as he is fully satisfied with the information provided by the PIO. Hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.


