JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-BDO, Nari CD Block, Lower Siang District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 20.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure & Implementation of work under MG-NGREGA/Supply work/Pending work/New work/Sanction Order/Complete work for the period 2018 to till date"

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of November'2023. The PIO was present and the appellant was also present. The PIO has provided the information as sought by the appellant and handed over the information to the appellant during the Court proceedings itself. The appellant has received the same and after going through the same, the appellant has expressed his satisfaction with the information provided by the PIO (letter enclosed) and pleaded the Court to dispose of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.


