ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/ PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Anini Division, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 15/01/2025 regarding **Augmentation and Retrofitting of Old Existing DC office at Anini in Dibang Valley District (Phase-1) during the financial year 2021-22.**

2). The 2nd hearing was held on 22nd July' 2025 (Tuesday) at 1100 hrs. The PIO-Cum-EE (PWD), Govt. of A.P., Anini Division, Dibang Valley District, Arunachal Pradesh was present in hybrid mode. Shri Tamchi Gungte, Appellant was also present in the court hearing.

3). Shri Tamchi Gungte, Appellant has informed the Commission that he had received all the furnished by the PIO-Cum-EE (PWD), Anini Division and satisfied with the information so furnished and requested the Commission to dispose of the case.
