The appellant file a RTI Application dated 27/06/2023 seeking Details regarding details of advertisement with reference to order No. & regularization procedure of ISSE/SSA Teachers through DPC. the

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 25/10/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Respondent : PIO-cum-DDSE, Seppa present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tadar Chai **27.06.2023** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director of School Education, East Kameng District, Seppa, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28.07.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **13.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 917/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 29/01/2025 and 17/03/2025. In this hearing of the appeal on 17th day of March, 2025, the PIO-cum-DDSE, Seppa present in person but the appellant Shri Rapung Lamgu found absent without any intimation to the Commission. The PIO has stated before the Commission today that all the information sought by the appellant has already been received by the appellant.

The appellant was directed to be present in the last hearing but he failed to obey the direction of the Commission. The Commission deems that the appellant has received the information and he is no more interested to pursue the appeal case.

Accordingly, the appeal case No. APIC-917/2023 is disposed off and closed.
