FACTS OF THE CASE:

The appellant filed an RTI application dated 12.12.2023 seeking information relating to departmental promotion exam of SPA since 2010-2022. The respondent PIO did not furnish reply to RTI application. The appellant then filed a First Appeal dated 09-03-2023. First Appellate Authority (FAA) order, if any, is not available on record. Feeling aggrieved and dissatisfied the appellant approached the commission with instant Second Appeal.

After receipt the Second Appeal notices were issued to the parties to appear on 03-11-2023.

RELEVANT FACTS EMERGING DURING HEARING:

The following are present:

Respondent: Respondent PIO is absent.

Appellant: Appellant is absent.

None appears before the commission despite duly served notices/summons dated 19.10.2023. However, the commission has received a letter dated 03.11.2023 from the PIO wherein he has submitted that appellant has withdrawn his application dated 22.12.2022. The PIO in his letter has further submitted that the appellant Shri Tatum Nyigang filed an appeal before the Hon'ble information commissioner Shri Gumjum Haider, seeking similar information and the appeal was disposed of on 04.08.2023. The appellant Shri Tatum Nyigang has also submitted a letter dated 20.07.2023 in which he has requested the commission to dispose of the case.

The commission based on a perusal of the facts on record observes that the instant case is squarely covered by the decision of this commission dated 04.08.2023 in another appeal filed by the same appellant. The commission is also in receipt of a petition for withdrawal of the present case and none of the parties has exercised objection to the petition for withdrawal during the hearing.

Having observed above, no action is warranted in the instant appeal. **This appeal is disposed of accordingly.**
