**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Riya Taram & Shri Takam Sakap, C/O Hotel River View, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-Executive Engineer, PWD Changlang Division, Changlang District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 03.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“To furnish all the relevant documents regarding the Allocation of fund Sanction Under SIDF/ RE/ Additional RE/ BE/ ADA/ MLALAD/ MPLAD/ SPA/ SJETA/CCI/ CMCSR/ SIDF & Additional which are implemented in all CD Blocks under PWD Changlang for the period 2015 to till date.”**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing for the case was held on the 22<sup>nd</sup> day of Nov' 2023. The PIO was present. Shri Tania June represented on behalf of the appellant. After hearing both the parties, the PIO had been directed by the Court to provide only the Sanction Order copies of the information as sought by the appellant on or before the next date of hearing of this case fixed on the 20<sup>th</sup> day of Dec'2023.

The 2<sup>nd</sup> hearing of this case was held on the 20<sup>th</sup> day of Dec'2023. Both the parties were present. After hearing both the parties, the PIO had been directed by the Court to furnish the documents pertaining with SIDF only for the year 2018-19 & 2019-20 on or before the next date of hearing of this case fixed on the 17<sup>th</sup> day of Jan'2024.

The 3<sup>rd</sup> hearing of this case was held on the 17<sup>th</sup> day of Jan'2024. The PIO was present, but the appellant was absent. During the hearing of this case, the PIO informed the Court/Commission that he had provided all the information as sought by the appellant. On this, the Court/Commission found that this case should be disposed as no more information needs to be provided to appellant and accordingly this case stands disposed of.

*Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
