**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhali, Lower Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/02/2023 regarding Expenditure and implementation of under Trans Arunachal Highway (TAH) Land Compensation payment of entire Lower Siang District.

**The 2<sup>nd</sup> hearing is held today on 17<sup>th</sup> October, 2023 as scheduled.** Shri Chogge Nyodu, the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhali, Lower Siang District, Arunachal Pradesh and the Appellant shri Tania June are absent.

The Commission viewed very seriously the negligence and violation of the provisions of the RTI Act 2005 by the SPIO inspite of warning during the 1<sup>st</sup> hearing. The Commission hereby gives last and final reasonable opportunity to the SPIO to furnish all the available correct and authenticated information to the Appellant and also directs Shri Chogge Nyodu, the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhali, Lower Siang District, Arunachal Pradesh to **Show Cause as to why penalty should not be imposed on him for gross violation of the RTI Act-2005.** The respondent is also directed to send his written submission along with all the supporting document upon which he chooses to reply during the hearing at least seven days prior to the actual date of hearing.

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the SPIO fails to appear the Commission shall impose penal provision under section 20(1) of the RTI Act and if Appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant is no more interested in the information.

The next date of hearing is fixed on 12<sup>th</sup> December, 2023 (Tuesday) at 1030 hrs.

Therefore, Shri Chogge Nyodu, the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Likhali, Lower Siang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
