JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Lebe Dolo , Polo Colony, Near Apex Bank, Naharlagun, Arunachal Pradesh** for non-furnishing of information, by the **PIO –cum-DCF, O/o the Principal Chief Conservator of Forest Itanagar, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 26.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

- 1. Furnish the Certify Copy of the Village Reserve Forest (VRF) made by Govt. of A.P through Forest Department as per the applicant's Annexure-I**
- 2. Furnish the Certify Copy of New Proposal made to Village Reserve Forest (VRF) made by Govt. of A.P through Forest Department as per the applicant's Annexure-I**

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 1st day of March'2023. Shri Karnya Kamdak, APIO (conservation) represented on behalf of the PIO. The appellant was also present. Heard both the parties. Information sought by the appellant has been provided by the APIO but the appellant has informed that some of the information aren't clearly visible and the information provided was incomplete. The Commission/Court has directed the PIO to furnish all the information relating to VRF on or before the next date hearing of this case fixed on the 26th day of April'2023.

The 2nd hearing for the case was held on the 26th day of April'2023. Both the parties were present. Heard both the parties. The appellant informed the Court that the documents furnished by the PIO is incomplete. The Court here directed the PIO to furnish the remaining documents on or before the next date of hearing of this case on the 17th day of May'2023.

The 3rd hearing of the case was held on the 17th day of May'2023. Both the parties were present. Heard both the parties. The Court/Commission ordered the PIO to swear in an Affidavit of the no information available in his office on or before the next date of hearing of this case fixed on the 7th day of June'2023.

The 4th hearing of this case was held on the 07th day of June'2023. Both the parties were present. Heard both the parties. The Sworn-in affidavit has been provided by the PIO during the Court proceedings itself and the appellant has informed that he is fully satisfied with the sworn-in affidavit and pleaded for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
