JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act. 2005. Brief fact of the case is that the appellant Miss Bengia Mama on 21.07.2023 filed an RTI application in Form-A to the Director Industries GoAP Itanagar Papum Pare District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the Director Industries, filed the First Appeal before the First Appellate Authority cum Director Industries GoAP Itanagar GoAP Itanagar on 12.09.2023.

Appellant again having not received decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 04.10.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.972/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 09.08.2024. Notice of hearing dated 21.06.2024 were served to FAA, PIO and the Appellant.

In this hearing of the appeal on 9.8.2024 the respondents PIO and FAA are absent. The appellant Miss Bengia Mama appeared.

Heard the appellant.

The appellant states that neither the PIO has furnished the information as sought in RTI application form 'A' nor the FAA – First Appellate Authority has heard the appeal within the prescribed time period in the RTI Act 2005. So, she has filed second appeal to this commission court.

On perusal of the case file, it is observed that the appellant filed RTI application in form - A to the Director Industries, Govt. of Arunachal Pradesh but not to the PIO of the Directorate office. In the first appeal again, she has filed to the Director Industries and the content in the first appeal is not matching with the content in the RTI application form - A. Thus, it renders in fructuous.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed at commission, hence this appeal stands disposed of and closed once for all. The liberty is given to the appellant to file correct RTI application afresh.
