1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Reema Jebisow, C/o Advocate Ajay Rigisow, District & Sessions Court Bomdila, West Kameng, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DFO, Forest Department, Bomdila, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/08/2024 regarding **details of CAMPA project sanctioned at Bihu Pam village sought segment, Buragaon (2023-24).**

2). The 3rd hearing was held on 3rd June'2025 (Tuesday) at 1100 hrs. Shri Obang Tayeng, PIO-Cum-DFO, forest Department, Bomdila, West Kameng District, Arunachal Pradesh was present in the court hearing and informed the Commission that in pursuance to court order passed on 6th May' 2025, the penalty amount of Rs. 25,000/- (Twenty five thousand) only had been deposited on 20th May' 2025 through Treasury Challan No. 1592530919646, and that all information as sought by the Appellant had been furnished.

3). The Appellant Ms Reema Jebisow, was not present in the court, however the Appellant had submitted a representation letter vide No. Dated 02/06/2025 addressed to the Commission informing that she had received all the information copy from the PIO-Cum-DFO, Bomdila and she is fully satisfied with the information so furnished by the PIO and requested the Commission to dispose of the case.

4). Based on the written input given by the Appellant, the Commission observes it fit to the dispose of the case.

Therefore, the case is hereby disposed.
