ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, PO/PS-Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Tezu, Lohit District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/11/2023 regarding the 14th Finance Commission in the year 2018-19 and 2019-20.
- 2). The 2nd hearing was held today on 21st January, 2025. The Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Tezu, Lohit District, Arunachal Pradesh, attended the hearing through telephonic call (audio). The Appellant Shri Mamu Sono was present in the court room.
- 3). The Appellant informed the Commission that he has received information from the PIO but the PIO has not furnished proper forwarding letter, indicating the replies serially as sought at Form-A dated 14/11/2023.
- 4). The Commission directed the PIO to furnish a proper forwarding letter to the Appellant with proper replies serially as sought for by the Appellant within 15 (fifteen) days from the date of issue of this order. In case, if any information as sought are not available the PIO should give reply through AFFIDAVIT. The PIO agreed to do so.

- 3). The Commission also directed the Appellant to give his confirmation to the Commission in writing after 15 (fifteen) days, but within 30(thirty) days from the date of issue of this order, failing which, the case would be disposed of without any further notice.
- 8). The case will be disposed of or the next date of hearing will be fixed on receipt of confirmation from the Appellant.
