**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June & Shri Nikam Dabu, C/o Post Office Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, RWD Daporijo Division, Upper Subansiri District, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 13.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**"To furnish the details of Name of Road, Road from Siga to Dayom(stage-ii), Package No. AR/10/04/015. Length 35.52 km. for the cost of Rs. 1,95,52,644 period from 2018 till Date."**

**The above subject has been mentioned in detail under 'Form – A'.**

The 1<sup>st</sup> hearing for the case was held on the 15<sup>th</sup> of February'2023. The PIO was present and the appellants were also present. Heard both the parties. Information sought by the appellants had been provided by the PIO during the Court proceedings itself. The appellant is directed to go through the same and should inform his satisfaction/dissatisfaction on or before the next hearing of this case fixed on 19<sup>th</sup> day of April'2023.

The 2<sup>nd</sup> hearing for the case was held on the 19<sup>th</sup> day of April'2023. The PIO was present and the appellants were also present. Heard both the parties. The appellants informed the Court that some particular papers were not clearly visible. Therefore, the Court has Directed the PIO to produce the particular papers to the appellants. The appellant should go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 24<sup>th</sup> day of May'2023

The 3<sup>rd</sup> hearing of the case was held on the 24<sup>th</sup> day of May'2023. Appellant Shri Nikam Dabu was present but the PIO was absent. The case was heard ex-parte. The appellant informed the court that he has received all the information as sought by him from the PIO and expressed that he is fully satisfied with the information provided by the PIO and pleaded for the disposal of the case. Hence, the case is disposed of.

**Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.**
