JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Post Office Naharlagun, E-Sector, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-SP, SIC, Itanagar, Capital Complex, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 01.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish the details of FIR under case Register/Non-Case Register/Govt. Approval Case/Pending Case/Regular Case/New FIR/Total FIR under SIC Office Itanagar (A.P) for the duration of 2014 to till date.”

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 9th day of August' 2023. Appellant was present. The representative of the PIO Inspector K. Tao was also present. Heard both the parties. The representative of the PIO has been directed to provide the total number of cases, disposed cases, pending cases, etc. indicating in total numbers only along with the present case status of Shri Tania June the appellant himself on or before the next date of hearing of this case fixed on the 30th day of August'2023.

The 2nd hearing for the case was held on the 30th day of August'2023. Appellant was present. The representative of the PIO Inspector Techhi Nega was also present. Heard both the parties. The representative of the PIO has been directed to provide the name of the complainant and against whom the case is registered in SIC(Vig.) PS on or before the next date of hearing of this case fixed on the 14th day of September'2023.

The 3rd hearing for the case was held on the 14th day of September'2023. The representative of the PIO Inspector K. Lama was present and the appellant was also present. Heard both the parties. The appellant has expressed his satisfaction over the information provided by the PIO. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
