Information sought :

The appellant file an RTI Application dated 14/03/2023 seeking Details regarding furnishing the true Certified copy of the appointment order in respect of Shri Gemar Kato, Shri Rakesh Bulu, Smti Kabak Yama, Shri Remesh Singkom, Smti Tado Sangita, Miss Kochak Gumja, Shri Kaning Dango, Shri Tomo Kamdak, Smti Yatang Taku and Miss Yaper Dagiam.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 24/05/2023. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Smti Karmu Tabi is represented by Shri Lebe Lamnio without any Authorization letter.

Respondent : PIO-cum-EE (PWD), Daporijo absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Smti Karmu Tabi on **14.03.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Daporijo Circle, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **24.05.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11.07.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 633/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for eleven times i.e on 18/09/2023, 06/11/2023, 11/12/2023, 29/01/2024, 29/04/2024, 17/06/2024, 12/08/2024, 09/0/2024, 11/11/2024, 10/02/2025 and 24/03/2025. In this hearing of the appeal on 24th day of March, 2025, the PIO-cum- (PWD), Daporijo Circle found absent however, he has submitted a copy of the forwarding letter vide letter dated 28/02/2025 for furnishing of the information to the appellant as per the Form 'A' application of the appellant which states that the PIO has provided the remaining information sought by the appellant. The Commission deems that the appellant is satisfied by the information provided by the PIO as he did not oppose to the information provided.

Accordingly, this appeal case No. APIC-633/2023 is disposed off and closed.
