**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Riya Taram, C/O Hotel River View, Barapani Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-Executive Engineer, PWD Rumgong Division, Siang District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 17.04.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“To furnish all the relevant documents regarding the Allocation of fund Sanction Under SIDF/ Additional BE/ Additional RE/ SADA/ ADA/ MLALAD/ MPLAD/ SPA/ SJETA/ CCI/ CMCSR with guidelines/BADP/ Maintenance/ Supply works for the period 2016 to till date.”**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing for the case was held on the 21<sup>st</sup> day of Dec' 2023. Appellant was absent. The representative of the PIO, Shri Kado Jini (AE) was present. During the hearing of this case, the representative of the PIO furnished the documents as sought by the appellant to the Court, which had been furnished to the appellant the next day. After going through the same the appellant has expressed his satisfaction with the information provided by the PIO and pleaded for the disposal of the case. Hence, the case is disposed of.

*Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
