JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on 24.07.2024 filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (WRD), Namsai Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 02.09.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 16.10.2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 283/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 10/03/2025. In this hearing of the appeal on 10th day of March, 2025, both the parties, PIO-cum-EE(WRD). Namsai Division and the appellant Shri Mamu Sono found absent, however, the appellant has submitted an application addressed to the Commission requesting to dispose off the appeal case No. APIC-288/2024. The appellant has also stated that all the information sought by him has already been provided by the PIO and he is satisfied with the information provided.

Request accepted and the appeal case No. APIC-283/2024 is disposed off and closed once for all.
