**Information sought :**

The appellant file an RTI Application dated 12/03/2025 seeking Details regarding Upgradation of Road from Kanubari to Ringpong (19 KM) (PH-II,, 3.00 km to 15.00 km) SH: 3.00 km to 5.200 km) in Longding District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 21/04/2025. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Chow Lajamang Mannow on **12.03.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Kanubari Division, Longding District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21.04.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.07.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 563/A/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 24/09/2025 and 08/12/2025. In this hearing of the appeal on 8<sup>th</sup> day of December, 2025, the parties PIO-cum- (PWD), Kanubari Division is represented by Er. Gyamar Taram, AE and the appellant Chow Lajamang Mannowm attended the hearing through VC.

On the 2<sup>nd</sup> hearing the PIO has brought all the information sought by the appellant but could not hand over to the appellant due to his nonappearance in person. But he is present through VC. The appellant was directed to collect the information within 15 (fifteen) days from the office of the PIO and intimate to the Commission whether he has received all the information or not. If no intimation is made, the Commission will presume that the appellant is satisfied by the information provided and the case will be decided accordingly.

As per the order dated 08/12/2025, appellant has submitted an application addressed to the Commission requesting to dispose of the Appeal case No. APIC-563/A/2025. Request accepted and the appeal case is disposed of and closed.
