An Appeal Case U/S 19(3) of RTI Act, 2005

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nyake Bojir and Sri Kijum Doke for non-furnishing of 19 (nineteen) point information regarding Untied Fund during 2024-25 by the PIO, o/o the E.E (RWD), Basar Division, Leparada District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 02.07.2025.

This appeal was heard earlier on 10.12.2025 where in the appellants, Shri Nyake Bojir and Sri Kijum Doke were present in person but the PIO was absent due to his pre-occupation in the election related training.

This Commission heard the appellants who acknowledged the receipt of the information/replies to some of the queries as per their RTI application but complained of incomplete information and pleaded for appropriate direction to the PIO to furnish the left out information/documents to them.

This Commission noticing that the left out information are not exempted under any of the exemption clauses As such the PIO was directed to furnish those left out information and/or appropriate replies by way of an affidavit to the appellants within 4(four) weeks from the date of receipt of this order and report compliance thereof on 30.01.2025, the next date of hearing.

Today on 30.01.2026, the appellants, Shri Shri Nyake Bojiris and Sri Kijum Doke are present in person. The AE-cum-APIO, Er. Shri Taba Riba is also present who submitted that he did not receive this Commission last order dt.10.12.2025 by which the PIO was directed to furnish the left out information and/or the affidavit to the appellants.

In the premises as above the PIO/APIO is granted 1(one) week more time to comply with the said order. The appellants shall, one week thereafter, intimate this Commission of the receipt of the information for further consideration of this appeal.
