**Information sought :**

The appellant file a RTI Application dated 30/10/2024 seeking Details regarding Release of fund amounting to Rs. 4,71,31,899/- under Special Assistant to State for Capital Investment (SASC) during the financial year 2022-23 for proper implementation of the Hydel connectivity from Hydel Station of Charju, Tirathju, Sumhok Nallah and Tehit to evacuate power to RK Mission School, Kendra Vidhalaya, Public Health Centre, Assam Rifle Camps of Dadam and Loyen in Border Areas of Tirap District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 26/11/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

### JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram on **30.10.2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer, (Electrical Division) Deomali, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **26.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.01.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 29/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 26/05/2025. In this hearing of the appeal on 26<sup>th</sup> day of May, 2025, both the parties, PIO-cum-Executive Engineer, (Electrical Division) Deomali and Shri Riya Taram found absent, however, the appellant Shri Riya Taram has submitted a letter addressed to the Hon'ble State Information Commissioner requesting to dispose off the appeal case No. APIC-29/2024 and stating that she has received all the information as sought by her and she is satisfied with the information provided.

Request accepted and disposed off and closed the appeal case No. APIC-29/2025.
