JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Lebe Dolo, Polo Colony, Near Apex Bank, Naharlagun, Arunachal Pradesh** for non-furnishing of information, by the **PIO –cum- DFO, O/o the DFO, Seppa, East Kameng District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 15.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“Village Reserve Forest (VRF)/ Anchal Forest Reserve (ARF) of entire East Kameng District, Arunachal Pradesh”

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 16th November,2023. The representative of the PIO, Shri Raju Yangfo Head Assistant Seppa Forest Division was present. The Appellant was also present. During the hearing of this case, the representative of the PIO had assured to provide the information as sought by the appellant on or before the next date of hearing of this case or else he would be imposed a penalty as per relevant sections of the RTI Act,2005 for diligently not performing his Statuary duties. The next date hearing of this case was fixed on the 20th day of December'2023.

The 2nd hearing for the case was held on the 20th day of December'2023. Both the parties were present. After hearing both the parties, information as sought by the appellant was furnished by the PIO during the hearing of this case. The appellant received the same and after going through the same, the appellant had expressed his satisfaction with the information provided by the PIO and pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
