The appellant file a RTI Application dated 29/10/2024 seeking Details regarding C/o Construction of Road from Palatari to Subu (L-15 KM) under Thrizino Circle, West Kameng District.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on 29/10/2024 filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 20/01/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17/03/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 255/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1 (one) time i.e on 10/09/2025. In this hearing of the appeal on 10th day of September, 2025, both the parties the PIO-cum-EE(PWD), Bomdila Division, West Kameng Subansiri District and the appellant Shri Tamchi Gungte found absent however, he sent a letter addressed to the Commission requested to dispose of the appeal case No, APIC-255/A/2025.

Request accepted and this appeal case is disposed of and closed.
