JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tasi Chader on 20.01.2023 filed an RTI application under Form-'A' before the PIO-Cum- Shri Hage Tabyo, O/o the SE, Subansiri Basin, Department of Hydro Power Development, Ziro, Lower subansiri District, Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27.02.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 29.03.2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 281/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 5 (five) times** i.e on **15.05.2023, 05.06.2023, 04.09.2023, 09.10.2023 & 16.10.2023.** In this hearing of the appeal on **16th** day of October,2023. Both the parties present during the hearing.

During the hearing, the PIO reported to the Commission as requested by the appellant in the last hearing he has furnished all the information including in the form of affidavit to the appellant.

Accordingly, the appellant intimated & submitted a letter to the Commission during the hearing, that he has received all the information as sought in the Form-' A' application and requested for disposal/closer of his appellant on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
