**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Nechang Kamke, Upper Niti Vihar, VIP Road Itanagar, Quarter No.21, Itanagar, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-DFO, Khellong Forest Division Bhalukpong, West Kameng District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 13.07.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**"i. CAMPA fund, ii. CAT Plan, iii. Avenue Plantation for the year 2016 to 2023 (till date)."**

**The above subject has been mentioned in detail under 'Form – A'.**

The 1<sup>st</sup> hearing for the case was held on the 31<sup>st</sup> Day of January' 2024. Both the parties were present. After hearing both the parties, the Court disposed of the case as the information sought by the appellant is vague. Hence, the case is disposed of. However, a liberty was given to the appellant to file a fresh case seeking information of particular project from the PIO.

*Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
