JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Kabak Mallam & Shri Medi Talin on **02.12.2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, PWD Division, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02.02.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07.03.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 210/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 9 (Nine) times i.e on **03.04.2023, 27.04.2023, 15.05.2023, 19.06.2023, 07.08.2023, 25.09.2023, 20.10.2023, 08.01.2024 & 02.02.2024**. In this hearing of the appeal on 2nd day of February, 2024. The appellant Shri Kabak Mallam present during the hearing but the PIO found absent.

However, the appellant submitted a letter during the hearing dated on **02.02.2024** to the Commission that the PIO has furnished all the information as sought by him in his form 'A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information as sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
