**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Lindum Amar, Vill.-Ranga, PO/PS-Tali, Kra Daadi District, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, RWD Division, Jamin-Camp Palin, Kra Daadi District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 28.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**"Yangte to Jhome PMGSY Road."**

**The above subject has been mentioned in detail under 'Form – A'.**

The 1<sup>st</sup> hearing for the case was held on the 31<sup>st</sup> day of January'2024. The appellant was absent but the representative of the PIO, Shri H. Dada (A.E) was present. During the hearing of this case, the representative of the PIO assured the Court that all the information as sought by the appellant had already been furnished to the appellant and that no more information were left to be furnished. Hence the case is disposed of.
