**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Riddam Kato, on 29/01/2024 filed an RTI application in form 'A' before the PIO-cum-Dy SP, Aalo, W/Siang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on 05/03/2024. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on 14/05/2024 and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. 207/2024 (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on 24/09/2024, 14/11/2024, 21/01/2025, 20/03/2025 & 05/6/2025. Details of Information sought from the PIO;

- i) **CTC of the list of the Police Station posted at Police Station.**
- ii) **CTC of the list of officials of the Police Station.**
- iii) **CTC of the copy of the handing and taking charge of the Police Station Aalo.**
- iv) **CTC of the copy of General Diary entry from 17<sup>th</sup> August 2023 to 17<sup>th</sup> September 2023.**
- v) **Periods for which information asked for 17<sup>th</sup> August to 17<sup>th</sup> Sept. 2023.**
- vi) **Other details: All relevant documents.**

In the final hearing of the Appeal on 5<sup>th</sup> June 2025. The Appellant Shri Riddam Kato, present during the hearing through online mode. The PIO also present through online mode.

Heard the Appellant.

The Appellant stated that he has received all the information(s) as sought in his Form-A application from the PIO and therefore, he has requested the Commission for disposal/closure of his appeal on ground of complete receipt of his information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, finds this appeal fit to be disposed and closed. And accordingly this appeal stands disposed and closed once for all.
