JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Riya Taram on **20/11/2024**, filed an RTI application under Form-'A' before the PIO-Cum- EE, (PHE & WS) Koloriang Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/10/2024**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/9/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-348/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for **5th hearing on 05/02/2026.**

Details of information Required:

1. Give the DPR copy.
2. Give the Govt. Sanction order/Technical Sanction(TS)copy/Sanction Amount for maintenance of water supply at Koloriang and Sarli Township at Amount of Rs. 1,50,00,000.00 and Rs. 60.00,000.00
3. To Give Administrative Approval Govt. Sanction Amount copy.
4. Give Name of contractor/Firm/Enterprise with their bank account number whom the work has been awarded.
5. Furnish the Estimates and quotation of all capital Expenditure and 5 equipment/description of work/Quantity/Rate/Amount.
6. Furnish the total Expenditure and Cash memo/Challan/Money receipt of the materials used in maintenance of water Supply
7. To furnish the Details report of the total household with the owners name & house no. in case where the maintenance have to be taken place.
8. Furnish the Bank account number of all the village Water and Sanitation Committees (vwsc) of 21" koloriang Assembly Constituency with mention the Chairperson and
9. Give the name of work List with Geo-tag Report/cashbook statement Secretary of the committee who jointly Operate it
10. Give the Xerox copy of ail the trading License/Firm/enterprise with their Bank account number. Give reason. What is the connection between Firm Owner/Proprietor and EE/AE/JE PHE&WS, Koloriang division who used the firm?
11. Give the List of work order/Supply order copy with first & final bill copy/cheque book counterfoil/cheque leaf/demand draft/banker cheque/treasury challan and PFS transaction details whether it might be paid as per the amount mentioned in work order/TS/sanction order copy.
12. Give the Money deposited slip/treasury challan deposited to the Govt.
13. Give the Money transaction/deposited/Bank account Statement records of Assist. Engineer (AE) bank account koloriang & Damin Sub-division from ET PHE & WS Account

14. Give Details of payment with money receipt of all the contractors/firm/enterprise.
15. Give the Loc/Loa which wrote to branch Manager SBI Koloriang with division Bank account number for Released of fund to Executive engineer account by chief engineer/SE. Give (MB) record with page no./hand receipt and payees name.
16. Give how many amount is applicable to deduct from contractor payment, give exact rate. ie hl/contingency/cess/Fr/it/GST.
17. Give the Contractor payment List.
18. Give certified photocopy of work site by concern officer.
19. Give the billing details Sheet & Scheme details Sheet copy.
20. Give NIT Copy/date of NIT tender float/total number of bidder/total apply of firm/name of Selected firm/enterprise/contractors/press Letter paper Cutting/awarded firm details/cheque book counterfoil/leaf with account number of Firm or Contractor to whom the payment has been made.

In the 5th hearing held on 5th day of Feb '2026, the Appellant found absent, with a letter dated 02/02/2026 submitted to the Commission the day before. The PIO -cum, Executive Engineer (PHE & WS) Koloring Division found absent during the hearing without intimating the reason for his inability to attend the hearing.

The Appellant Shri Riya Taram, has submitted a letter to the Commission on 02/02/2026 stating that he has received all the information(s) as sought in his Form 'A' application and he requested the Commission for disposal/closure of his appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


