JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Riya Taram, C/O Hotel River View, Barapani Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-Executive Engineer, PWD Mechuka Division, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 14.03.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish all the relevant documents regarding the Allocation of fund Sanction Under SIDF/ Additional BE/ Additional RE/ SADA/ ADA/ MLALAD/ MPLAD/ SPA/ SJETA/ CMCSR or maintenance and Supply Works/ Order implemented for development Mechuka Division, for the period 2017 to till date.”

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 22nd day of Nov' 2023. The PIO was absent. Shri Tania June represented on behalf of the appellant. A 2nd Summon Notice to be issued to the PIO for his personal appearance on the next date of hearing of this case fixed on the 20th day of Dec'2023.

The 2nd hearing of this case was held on the 20th day of Dec'2023. The representative of the PIO, Er. R. Tasso (AE) was present, and the appellant was also present. After hearing both the parties, the representative of the PIO had provided the information as sought by the appellant during the hearing of this case. The appellant received the same and pleaded the Court to provide some more time to go through the same and would inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 17th day of Jan'2024.

The 3rd hearing of this case was held on the 17th day of Jan'2024. The representative of the PIO was present, but the appellant was absent. During the hearing of this case, the representative of the PIO informed the Court/Commission that he had provided all the information as sought by the appellant in the previous hearing and the appellant sought some more time to go through the same and would inform his satisfaction/dissatisfaction on or before today's hearing. But the appellant was found absent, which seem that he is fully satisfied with the information provided and does not want to pursue this case further. Hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
