**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Riya Taram, Adv. Bengia Tahar & L.Namdu, Riang Store near Cahtolic Church, Jollang Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Roing Division, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/12/2024 regarding the relevant information against Name of Scheme / work list under Funding head of SIDF (2016-24).
- 2). The 2<sup>nd</sup> hearing was held on 8<sup>th</sup> July' 2025. The PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Roing Division, Lower Dibang Valley District, Arunachal Pradesh was represented by Shri Vikash Bagang, APIO-cum-JE (PWD). The Appellants, Adv. Riya Taram, Adv. Bengia Tahar & L.Namdu were found absent. The Appellant, Adv. Riya Taram had submitted a letter No. nil dated 8/7/2025 requesting for adjournment of case.
- 3). The APIO Submitted that as per the direction of the Commission, information had been kept ready in electronic digital form ( CD ) and additional hard copy to be furnished to the Appellant but no one turned up to collect the information.
- 4). The Commission directed the Appellant to collect information from the office of the PIO and the PIO was also directed to furnish information free of cost to the Appellant under section 7(6) of the RTI Act, 2005 as an when the Appellant visits the office.
- 5). The Commission, in view of caution given in the 1<sup>st</sup> hearing held on 3rd June'2025 to dispose of the case in case of absence by the Appellant, hereby decides to dispose of the case. The Appellant's last moment request for adjournment is too late to be entertained. However, the Appellant has liberty to appeal against the decision of the Commission under article 226 of the Indian Constitution.

6). Therefore, the case is hereby disposed of.
