ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June and Shri Nikam Dabu, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-EE(PWD), Govt. of A.P. Yazali Division, Ziro-II, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/10/2022 regarding improvement of road from Linia to Loth Circle office HQ. Lower Subansiri (L-4.00km) cost of Rs. 296.00 lakhs.

The 1st hearing is held today on 22nd August, 2023 as scheduled. The SPIO-cum-EE(PWD), Govt. of A.P. Yazali Division, Ziro-II, Lower Subansiri District, Arunachal Pradesh is represented by shri Bengia Chito, UDC. The Appellant Shri Tania June is present. The Appellant has submitted that though he has received some of the information, yet many of the information sought for are yet to be furnished. The representative of the respondent submitted that the remaining information would be provided within a week time from today. The SPIO is directed to furnish information in a weeks time as assured by him, failing which penal action shall be initiated under section 20(1).

The matter came up for 2nd hearing held on 10th October' 2023 (Tuesday) at 1030 hrs. The representative of SPIO-Cum-EE(PWD), Yazali Division, Ziro-II, Lower Subansiri District, Arunachal Pradesh is represented by Shri Bengia Chito, UDC. Shri Abang Yangfo has represented the Appellant Shri Tania June. The Appellant submitted that he has received all the remaining information from the SPIO as sought by him in form "A". The appellant found fully satisfied with the information so furnished by the SPIO and requested the Commission to disposed of the case.

On being satisfied by the Appellant, the Commission observed it fit to be disposed of the case.

Hence, the case is disposed of and closed.
