JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Takar Niji on **21.04.2023** filed an RTI application under Form-'A' before the PIO-Cum- EE, PWD Division, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07.06.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21.07.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APICs No. 663/2023 & 664/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (four) times** i.e on **18.09.2023, 06.11.2023, 11.12.2023 & 29.01.2024** In this hearing of the appeal on **29th** day of January,2024. Both the parties found absent during the hearing.

However, the appellant submitted a letter dated on **28/01/2024** to the Commission that the **PIO has furnished all the information as sought by him in his form 'A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information as sought from the PIO.**

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
