JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on 15/10/2025 filed an RTI application under Form-'A' before the PIO-Cum- EE, (PRD) Papum-pare Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not receiving the information from the PIO, filed the First Appeal before the First Appellate Authority on 20/11/2025, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17/10/2025 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-76/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on 6/05/2025, 31/07/205 & 11//11/2025.

Details of information sought by the Appellant.

- 1. Furnish the certified Sanction Order Copy.
- 2. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status with the Districts as per Rule 4(ii)(b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015.
- 3. Furnish the certified LOC Copy with respect to the subject mentioned above.
- 4. Furnish the certified copy of Utilization Certificate.
- 5. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
- 6. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
- 7. Furnish the certified copy of Completion certificate of the project.
- 8. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Localj) along with date of publication of Newspaper, as per Government approved Order.
- 9. Furnish the certified Design and Scope of Work in the projects.
- 10. Furnish the certified copy of Work Specification of the projects.
- 11. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
- 12. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
- 13. Furnish the Name of Officers and their Designation at the Time of monitoring the work
- 14. Furnish the certified copy of Contractor Registration, Pass work Completion, Contractor Enlistment Update reports, of tender participant and winning Firm.
- 15. Furnish the certified copy of EMD and Security money deposited by allthe tender participant.
- 16. Furnish the certified Integrity Pact submitted by the tender participant.
- 17. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing

- commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018).
- 18. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similars work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 50% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
- 19. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm

In the 3rd hearing on 11th day of November '2025, the Appellant found absent, with a letter dated 11/11/2025, submitted to the Commission the day before. The PIO –cum, Executive Engineer (PWD) Ziro Lower Subansiri, present during the hearing in person.

The Appellant Shri Tamchi Gungte has submitted a letter to the Commission on 11/11//2025, stating that he has received allthe information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
