**Information sought :**

The appellant file an RTI Application dated 14/10/2024 seeking Details regarding Construction of road from Komsing Bridge point to Mopit Village under Siang District (Phase-I)

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 27/12/2024. The First Appellate Authority has conducted the hearing on 06/02/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte **14/10/2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Boleng Division, Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on

27/12/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 03.04.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 304/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2(two) times i.e on 03/09/2025 and 03/11/2025. In this hearing of the appeal on 3<sup>rd</sup> day of November, 2025, the PIO-cum-EE (PWD), Boleng Division, Siang District is represented by Er. Jumra Hankar, APIO but the appellant Shri Tamchi Gungte found absent without any intimation to then Commission.

As per the case record, it is seen that during the hearing before First Appellate Authority, the appellant was absent for 3 (three) consecutive hearings and accordingly, the First Appellate Authority have disposed of the case citing that the appellant has no more interested to pursue the appeal case. It is also seen that the PIO have furnished and submitted all the sought documents before the First Appellate Authority along with covering letter but due to absence of the appellant the sought documents could not be handed over to him.

During the last hearing, the appellant was cautioned to intimate before the Commission after collection of the information which is already available before the First Appellate Authority. If no intimation is made, the case will be heard in his absence.

Today the appellant is found absent. Sufficient chance is already given to the appellant to collect the information from the First Appellate Authority and the Commission.

Therefore, the commission deems that the appellant is no more interested to pursue this appeal case. The appeal case No. APIC-304/A/2025 is therefore disposed of and closed in his absence.
