- Furnish the Geo-tag of 10 Corners of each plantation, 4 photographs of 12 nos of each plantation.

- e) Furnish the distance from highway of each plantation.
- f) Furnish the map in scale of each plantation created.
- g) Furnish the total expenditure incurred in each plantation created in Moruk and Dambuk Artificial Plantation.
