Information sought :

The appellant file an RTI Application dated 21/04/2025 seeking Details regarding creation of Barrier free in 18 buildings in Longding District against the Scheme for implementation of the Right of Persons with Disabilities Act, 2016 (SIPDA) for the CFY 2021-2022.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 06/06/2025. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

Respondent : PIO-cum-EE (PWD), Longding Division is represented by Er. Dongda Taduk, JE.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Pumcho Talok on **21.04.2025** filed an RTI application under Form-‘A’ before the PIO-cum-Executive Engineer (PWD), Longding Division, Longding District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **06.06.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12.07.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 612/A/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 03/12/2025. In this hearing of the appeal on 3rd day of December, 2025, the PIO-cum-(PWD), Longding Division is represented by Er. Dongda Taduk, JE and the appellant Shri Pumcho Talok is represented by Counsel, Adv. Dope Ori.

On the 1st hearing the PIO has brought all the information as sought by the appellant and handed over to the Counsel Adv. Dope Ori on behalf of the appellant before the Commission. The appellant was directed to go through the information provided and intimate to the Commission on or before 8/12/2025.

If no intimation is received from the appellant the Commission will presume that the appellant has been provided all the information and is satisfied and accordingly the case will be decided.

As per the order dated 03/12/2025, the appellant through his Counsel, Adv. Dope Ori informed the Commission that the appellant has received all the information. So he requested the Commission to dispose of the appeal case No. APIC-612/A/2025. Request accepted and the appeal case No. APIC- 612/A/2025 is disposed of and closed.
